Guidelines

- II. Each entry uses no more than 5 colours
- III. Entries must bear no signatures or any personal signals
- IV. With every entry, a rational is mandatory to hand in (explanation of the logo, colour, design, ...)
- V. Entries can be submitted until 1 March 2019, 11:59pm
- VI. All entries must be sent to contest@mgs.org.my
- VII. Entries will not be accepted if:
 - i. automatically generated by computer
 - ii. completed by third parties or in bulk
 - iii. illegible
 - iv. have been altered, reconstructed, forged or tampered with
 - v. incomplete
- VIII. The following points are not allowed:
 - i. made on behalf of another person
 - ii. joint submissions by two or more persons
 - iii. made by or on behalf of a partnership or company or other body corporate

Prizes
